

## MEMBERSHIP CERTIFICATE

### APPLICATION FOR WATER AND SEWER SERVICE WATER AND SEWER USER'S AGREEMENT

The undersigned being the owner of land located within the above Rural Water and Sewer District hereby makes application to said Rural Water and Sewer District No. 4, Lincoln County, Oklahoma for water and/or sewer services and agrees to the following conditions:

1. Purchase or cause to be purchased one (1) Membership for such service at a price of **\$3,500.00.** Purchase or cause to be purchased one (1) Sewer Tap for such service at a price of **N/A.**
2. Pay a minimum monthly Membership charge to be established by the Board of Directors, for water and sewer service from the time service is made available by the district and pay for additional water used at the rate set out in the rate schedule adopted by the Board of Directors. Any changes made in the minimum monthly water and sewer charges and rate schedule by the Board of Directors of the district shall become a part of this Agreement as though fully set out herein.
3. When the Rules and Regulations of the district provide that the district will read the water meters and submit bills for water and sewer service. These bills shall be rendered by the district on or before the 1<sup>st</sup> day of the month following the month in which the water and sewer service is used. The undersigned agrees to pay said service bill on or before the 10<sup>th</sup> day of the month in which the bill is rendered or be subject to a late charge as designated by the Board of Directors. Failure of the district to submit a service bill shall not excuse the undersigned from his obligation to pay for the water and sewer service used at the time the water and sewer bills are submitted. Failure to pay a bill following the month in which the bill is rendered may result in discontinuance of the service.
4. The services supplied by the district shall be for the sole use of the undersigned; the undersigned agrees that he will not extend or permit the extension of pipes for transferring water from one property to another, nor will he share, resell, or sub-meter water to any other consumer or allow any other user to connect to sewer line. Each meter service shall supply water and sewer service to only one residence or business establishment located on land within the district.

5. If after water or sewer service is made available the same is discontinued or disconnected for any purpose, pursuant to the Bylaws and the Rules and Regulations of the district, reconnection shall be upon the conditions set out by the Board of Directors of the district.
6. The undersigned agrees the he will make no physical connection between any private water system and the water system of the district.

**REPRESENTATIVES OF THE DISTRICT MAY AT ANY REASONABLE TIME COME ON THE PREMISES WHERE THE WATER AND OR SEWER IS BEING USED FOR THE PURPOSE OF MAKING INSPECTIONS TO ENFORCE THIS PROVISION. VIOLATION OF THIS PROVISION SHALL BE GROUNDS FOR DISCONNECTION OF SERVICE.**

7. The laws of the State of Oklahoma, the Bylaws of the district, and the Rules and Regulations of the district, as presently existing, and as may be amended from time to time are made a part of this Agreement as though fully set out herein.
8. Each Membership must provide the District with a filed copy of deed showing ownership. The tract or tracts to which each Membership is to be assigned must be listed on deed or deeds.
9. Each applicant for water and sewer service must give a **perpetual easement** for the lines crossing his land. Water lines are normally located 5 feet inside the fence line.
